

Advance Purchase of **2026 April – June Limited Edition Pin Pre-sale Package** -

Terms and Conditions

Purchase of Package

1. From April 1 to April 7, 2026 (“**Advance Purchase Period**”), any guest who has purchased the 2026 January – March Limited Edition Pin Pre-sale Package (“**2026 January – March Package**”) (such guest, “**Eligible Guest**”) may purchase the 2026 April – June Limited Edition Pin Pre-sale Package (“**Value Package**”), subject to these terms and conditions and availability.
2. Hong Kong International Theme Parks Limited (“**HKITP**”) will make available up to 150 Value Packages during the Advance Purchase Period for purchase by Eligible Guests at Hong Kong Disneyland The Archive Shop (“**Location**”) in Hong Kong Disneyland Park (“**Park**”) during its operating hours until 6pm. Each Value Package consists of (i) 6 designated Limited Edition Pins, (ii) the Package Exclusive Limited Edition Pin – MeiMei, and is priced at HK\$1,334. In these terms and conditions, “**Package(s)**” means the Value Package and “**Package Pin(s)**” shall mean pin(s) in a Package.
3. Existing Magic Access Members may enjoy the following discount on the purchase price of the Magic Access Package: Platinum Magic Access Members may enjoy 20% discount, Gold and Silver Magic Access Members may enjoy 10% discount. To enjoy any Magic Access discount HKITP may from time to time offer in respect of the Magic Access Package, Magic Access Members are required to present his/her valid Magic Access Membership Card in person upon purchase.
4. To purchase a Package(s) during the Advance Purchase Period, Eligible Guest is required to present his/her valid original sales receipt for the 2026 January – March Package at the Location in person.
5. The maximum quantity of Package(s) each Eligible Guest may purchase is up to the same quantity of the 2026 January – March Package as printed on his/her original sale receipt for the 2026 January – March Package. Each valid original sale receipt for the 2026 January – March Package may be used once only and will be stamped upon usage.
6. Guests who have purchased the Package(s) will be eligible to purchase the 2026 July - September Limited Edition Pin Pre-sale Package by presenting the original sale receipt for the Package(s). The types, retail price, sale period and other terms and features of the 2026 July - September Limited Edition Pin Pre-sale Package will be announced in due course.

7. Upon purchase of the Package(s), redemption vouchers (“**Vouchers**”) will be issued. The Package(s) purchased, the name of the purchasing guest and (if applicable) his/her Magic Access Membership Card number will be recorded on the Vouchers and cannot be changed.
8. Vouchers and original sale receipts may only be used by the purchasing guest in person. Guest is required to present his/her personal identification (and for Magic Access Member, his/her valid Magic Access Membership Card) in person at the time of purchasing the Package(s), collecting the Vouchers and redeeming the Package Pins. HKITP reserves the right to refuse issue of the Vouchers and/or redemption of the Package Pins if the guest’s identity and eligibility requirement cannot be verified.
9. The Package(s) Pins are for the guest’s personal use only. The Vouchers and Package Pins are non-transferable, non-refundable and non-exchangeable for cash, credit or any other items and not for resale.
10. Except as provided in paragraph 3 above, the Package(s) may not be purchased with any other coupon, offer or discount.

Pin Redemption

11. To redeem Package Pins, guests are required to present the corresponding Vouchers during the respective redemption periods according to the redemption schedule available at the following link: [View redemption schedule and Term and Conditions](#)
12. Information relating to the Package(s) and the Package Pins (including but not limited to, the sale period, types, retail price, available quantity, redemption arrangement and other features) set out in these terms and conditions are for reference only. HKITP may from time to time change (including but not limited to) the sale period, types, retail price, available quantity, redemption arrangement and other features of the Package(s) and the Package Pins available for sale at its sole and absolute discretion.
13. HKITP shall not be responsible for and will not provide any compensation, exchange or replacement of any Package Pin, or if any guest is unable to redeem any Package Pin or any version of the Package Pins for any reason.
14. Vouchers cannot be used in conjunction with any other coupon, offer or discounts.
15. Price of the Package(s) does not include admission to the Park. Vouchers cannot be used as Park admission and guest must have valid admission ticket to enter the Park for redemption.

16. Photocopy of Vouchers will not be accepted. Vouchers are voided if damaged, altered or tampered with. No replacement in respect of lost Vouchers will be issued.
17. Each Voucher is for one-time use only and will be collected by HKITP upon usage.
18. Vouchers not used during the designated redemption period will be voided without refund or compensation.

General terms

19. Duplicated, used or incomplete Voucher or original sale receipts will not be accepted. Vouchers and original sale receipts are voided if altered or tampered with. HKITP shall not be responsible for (and will not issue replacement in respect of) any loss, damage, forgery, theft or fraudulent or unauthorized use of Vouchers and/or original sale receipts. HKITP's record in relation to issue and usage of Vouchers and original sale receipts shall be final and conclusive.
20. Request for refund due to any defect in any Package Pin must be made at the time of pin redemption. Refund will only be made after the guest returns all redeemed Package Pins and unused Vouchers to HKITP and HKITP is satisfied that the Package Pin is defective at the time of redemption. Refund will be made to the credit card used to purchase the Package(s).
21. HKITP reserves the right to determine the prices of merchandise and the operating hours of stores and the Location at its sole and absolute discretion.
22. These terms and conditions are subject to the interpretation of HKITP which shall be final and conclusive. In case of disputes, HKITP reserves the right of final decision on the dispute, and otherwise, in respect of the Package(s). In the event of any conflict of inconsistency between the English and Chinese versions of these terms and conditions, the English version shall prevail.
23. These terms and conditions shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China ("**Hong Kong**"). The Package(s) are offered in accordance with the laws of the Hong Kong only. Those who choose to purchase the Package(s) and/or collect the Vouchers and/or redeem the Package Pins do so on their own initiative and are responsible for compliance with local laws, if and to the extent they are applicable.
24. These terms and conditions constitute an agreement between HKITP and each guest purchasing the Package(s). A person who is not a party to this agreement

shall not have any rights under the Contracts (Rights of Third Parties) Ordinance (Chapter 623 of the Laws of Hong Kong) to enforce any term of this agreement.
