

Advance Purchase of **Pin Trading Carnival 2026 Pin Package** - Terms and

Conditions

Purchase of Package

1. From August 1 to 7, 2026 ("Advance Purchase Period"), guest who has purchased the 2026 July to September Limited Edition Pin Pre-sale Package ("2026 July to September Package ") (such guest, "Eligible Guest") may purchase the Pin Trading Carnival 2026 Pin Package ("Package"), subject to these terms and conditions and availability.
2. Hongkong International Theme Parks Limited ("HKITP") will make available up to 150 Packages during the Advance Purchase Period for purchase by Eligible Guests at The Archive Shop ("Location") in Hong Kong Disneyland Park ("Park") during its operating hours, while stocks last. Each Package consists of 3 limited edition pins and 1 style of open edition mystery pin box (each a "Package Pin"), and is priced at HK\$1,336.
3. Existing Magic Access Members may enjoy the following discount on the Package price: Platinum Magic Access Members may enjoy 20% discount, Gold and Silver Magic Access Member may enjoy 10% discount. To enjoy any Magic Access discount HKITP may from time to time offer in respect of the Package, Magic Access Members are required to present his/her valid Magic Access Membership Card in person upon purchase.
4. To purchase the Package in advance, Eligible Guest is required to present his/her valid original sales receipt for the 2026 July to September Package at the Location in person.
5. The maximum number of Packages that each Eligible Guest may purchase shall be limited to the same quantity of the 2026 July–September Package as indicated on the original sales receipt for the 2026 July–September Package. Each valid original sales receipt for the 2026 July–September Package may be used for one purchase only and will be stamped upon usage.
6. Guest who has purchased the Package(s) will be eligible to purchase "Pin Trading Carnival 2026" – Flounder Pin by presenting the original sale receipt for the Package(s). The retail price, sale period and other terms and features will be announced in due course.
7. Original sale receipt may only be used by the purchasing guest in person. Guest is required to present his/her personal identification (and for Magic Access Member,

his/her valid Magic Access Membership Card) in person at the time of purchasing the Package and redeeming the Package Pins. HKITP reserves the right to refuse issue of the redemption of the Package Pins if the guest's identity and eligibility requirement cannot be verified.

8. The Packages are for the guest's personal use only. The Packages and Package Pins are non-transferable, non-refundable and non-exchangeable for cash, credit or any other items and not for resale.
9. Except as provided in paragraph 3 above, the Packages may not be purchased with any other coupon, offer or discount.

Pin Redemption

10. Guests who have purchased the package may redeem their package pin immediately: [View redemption schedule and Term and Conditions](#)
11. Information relating to the Package and the Package Pins (including but not limited to, the sale period, types, retail price, available quantity, redemption arrangement and other features) set out in these terms and conditions are for reference only. HKITP may from time to time change (including but not limited to) the sale period, types, retail price, available quantity, redemption arrangement and other features of the Package and the Package Pins available for sale at its sole and absolute discretion.

General terms

12. Request for refund due to any defect in any Package Pin must be made at the time of pin redemption. Refund will only be made after the guest returns all redeemed Package Pins to HKITP and HKITP is satisfied that the Package Pin is defective at the time of redemption. Refund will be made to the credit card used to purchase the Package.
13. HKITP reserves the right to determine the prices of merchandise and the operating hours of stores and the Location at its sole and absolute discretion.
14. These terms and conditions are subject to the interpretation of HKITP which shall be final and conclusive. In case of disputes, HKITP reserves the right of final decision on the dispute, and otherwise, in respect of the Package. In the event of any conflict of inconsistency between the English and Chinese versions of these terms and conditions, the English version shall prevail.
15. These terms and conditions shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic

of China ("Hong Kong"). The Packages are offered in accordance with the laws of the Hong Kong only. Those who choose to purchase the Package and/or collect the Vouchers and/or redeem the Package Pins do so on their own initiative and are responsible for compliance with local laws, if and to the extent they are applicable.

16. These terms and conditions constitute an agreement between HKITP and each guest purchasing the Package. A person who is not a party to this agreement shall not have any rights under the Contracts (Rights of Third Parties) Ordinance (Chapter 623 of the Laws of Hong Kong) to enforce any term of this agreement.
