  ("Eligible Guests").

During the Promotion Period, Eligible Guests may (i) sign in to his/her MyDisney HK account, and (ii) register his/her valid admission ticket, Magic Access Personalised Membership Card or corporate membership card used for admission to the Hong Kong Disneyland Park ("Park") before or within 30 days of Park admission to receive one electronic PhotoPass coupon issued by HKITP ("Coupon").
- 3. Eligible Member may register for the Coupon during the Promotion Period before or within 30 days from Park admission with his/her valid MyDisney HK account via the website or Hong Kong Disneyland app. Each Park ticket or membership card may only be used once to register for one Coupon during the Promotion Period. Park tickets or membership cards which have been used to register a Coupon may not be used to register for the Coupon. This Promotion is only valid for photos taken by photographers in Disney PhotoPass costume ("**Disney PhotoPass Photographers**") in the Park and the onride photo capture at designated attractions.
