3-DAY WEEKDAY THEME PARK TICKET WITH LIGHTNING LANE MULTI PASS

Members enrolled in the 2026 Membership Magic Beyond Option can purchase a 3-day weekday ticket that allows access to Disneyland® Resort theme parks on most weekdays (Monday through Friday) and includes Lightning Lane Multi-Pass.

Tickets must be purchased during the 2026 Benefit Season on or before December 28, 2026. Tickets may only be purchased by the Member enrolled in the Optional Benefit Program for themselves and up to seven (7) guests in the Member's traveling party, for up to a total of eight (8) WDW Tickets per the 2026 Benefit Season. Special Weekday 3-Day tickets are valid only on weekdays beginning on January 12, 2026 and expire 13 days after first use or on December 18, 2026, whichever occurs first. Tickets are blocked out every Saturday and Sunday during the ticket validity period and on 12/21/26, 12/22/26, 12/23/26, 12/24/26, 12/25/26, 12/28/26, 12/29/26, 12/30/26, 12/31/26. Special Peak Weekday 3-Day tickets are valid only on weekdays beginning January 12, 2026 and expire 13 days after first use or on December 31, 2026. Tickets are blocked out every Saturday and Sunday during the ticket validity period. Each day of use constitutes one full day of use. The enrollee must accompany their guests for whom they purchased the tickets, and one of the tickets purchased must be used by the enrollee. Each ticket must be used by the same person on any and all days. Tickets are nonrefundable, may not be sold or transferred for commercial use, and exclude activities/events separately priced. May not be combined with other ticket discounts or promotions. Subject to restrictions, changes, and cancellation without notice. Sales may be paused from time to time or terminated at any time.

Tickets require the Member to choose the dates of visit at the time of purchase in order to make park reservations for such dates.
